For many young ladies, participating in a program like this and earning the opportunity to represent their city is a very rewarding and exciting experience. Often times, the experiences gained result in personal growth and lifelong relationships. We are certain you will have many questions about the program and we will attempt to answer as many as possible. This contestant handbook contains the information you need to help you prepare for the program. Please read all the information and feel free to contact the Board of Directors if you have any questions.

One of the most important documents you will find in this handbook is a checklist of required paperwork. This checklist is for your convenience and does not need to be returned. All the papers behind it are to be completed and returned to the program by the deadline stated. These papers set themselves apart as they have the Inver Grove Heights Scholarship Program logo on top of each sheet. Please do not alter the official paperwork in any way (i.e. adding your photo to the official bio form, etc.) Altered paperwork will be returned.

My advice is to get as much done as soon as you can. Do not wait until the last minute or you may feel rushed. While it is not required to type the official application, please feel free to do so if you feel for any reason the judges may have difficulty reading your handwriting. Please ensure the full completion of all paperwork and avoid misrepresentation, as this may lead to automatic disqualification.

It is highly suggested that each candidate brings this handbook with her to orientation. We will go over judging, royalty expectations, and schedules in great detail. Making notes in your handbook is a great way to keep all information in one location. A parent/guardian is required to attend orientation with each contestant so please plan accordingly.

JUDGING CRITERIA

Royalty will be selected to act as ambassadors for the City of Inver Grove Heights and the Inver Grove Heights Scholarship Program. Royalty must be outgoing and able to meet and greet the public with ease. They will need to be comfortable with public speaking and ready to speak at all appearances. Most importantly, all of the young ladies selected for the Royal Family must be able to work together as a team.

The judges will consider the following characteristics:

- Poise
- Communication Skills
- Intelligence
- Good Manners
- Grooming
- Warmth
- Friendliness
- Sense of Humor
- Ability to relate well to people of all ages
- Leadership skills

All candidates will be judged fairly and regardless of their sponsor. Physical characteristics will not be a factor in selecting the royalty.

Candidates will be judged in formal and informal settings. Formal judging events will include: one-on-one interviews, panel interviews, the fundraising dinner, fundraising, and coronation.

At several events, candidates will be asked to draw a random question and answer this question. These questions may be from several diverse subject areas. One candidate may receive a question regarding her philosophy on a subject while another candidate may get a question about her favorite childhood memory. All questions allow the judges to see the individual's personality and nature.
